- 2. Revised Fire Safety Certificate
- 3. 7 Day (Commencement) Notice
- 4. Fire Regularisation Certificate

4 Types of FSC in Part III of BC

A Regularisation Certificate is granted by a Building Contest Authority in respect of works on non-domestic buildings and apartments blocks which were commenced or completed without the necessary fire safety certificate (FSC). The certificate may be granted with or without conditions or refused.

### **Building Regulations** Schedule 2 Part B – Fire Safety

Parts B1 to B5 apply to the design and build, but only Part B.

### **Building Control Act 1990**

 Limitation on civil proceedings: Section 21.—A person shall not be entitled to bring any civil proceedings pursuant to this Act by reason only of the contravention of any provision of this Act, or of any order or regulation made thereunder.

## **Building Control Regs** – Part III Article 20C Regularisation Certificate

- A building control authority shall, having considered an application for a regularisation certificate and following an inspection of the building, grant such certificate, with or without conditions or refuse.
- An **authorised person** shall be entitled to enter at all reasonable times into any land (need CE Order authorisation) and inspect, for the purposes of these Regulations, any building and any plans or documents relating to such building.
- A regularisation certificate granted under this Part shall only be construed as specifying, that in the opinion of the building control authority, the works as comply with the requirements of Part B, subject to compliance (within a period of 4 months there mentioned) with any conditions.
- This Application Form for a Regularisation Certificate must be accompanied by a **Statutory Declaration**.

### **Legislation - Statutory Declaration**



### Regularisation Certificate Statutory Declaration.

- Do solemnly and sincerely declare that the drawings, documents and information supplied in relation to the attached application for a Regularisation Certificate for the building as constructed or in respect of works already carried out to date, pursuant to article 20 C of the Building Control Regulations 1997 to 2009 are true and accurate and that the works comply fully with Part B (Fire Safety) of the Second Schedule to the Building Regulations.
- Solemnly declare to **agree to inspection** of the works/building by the Building Control Authority in carrying out its functions under the Act.
- Solemnly declare to **abide by any conditions**, including conditions to carry out additional work considered appropriate by the Building Control Authority necessary to enable the authority to issue a Regularisation Certificate.
- Accept that where the conditions attached to the Regularisation Certificate are not fully complied with to the satisfaction of the Building Control Authority within a period of 4 months from the date of issue of the Regularisation Certificate, the Certificate shall not have effect.




- BC Regs state application must include:
- S.I. No. 351 of 2009 Art 20C: Accompanied by drawings of the relevant works as they have been commenced or constructed, so as to enable the building control authority to assess whether the said works, as commenced or as constructed in accordance with the said drawings, documents and information submitted, will comply or are in compliance, as appropriate, with the requirements of Part B of the Second Schedule to the Building Regulations.
- BC Regs Third Schedule Fire Reg form: This Application Form must be
  accompanied by a complete and certified set of drawings for the
  works or building as commenced or constructed. Plus the statutory
  declaration.

### **Fire Reg Inspection**

### Main steps

- Contact the Consultant to arrange an inspection
- Carry out inspection
- Based on that inspection we decide to recommend
  - that they fix the outstanding issues before we are willing to grant. This means a second inspection and can mean time extensions.
  - grant with the FSC conditions from FSC assessment
  - grant with additional conditions, as well as the FSC conditions, to capture
    outstanding issues discovered during the inspection. Ideally, there should be
    another inspection at the end of the 4 months.
  - Refuse because the works do not comply with the drawings/compliance report or do not comply with Part B.

### Whats needed for the Inspection

- Bring FSC Drawings/Compliance report
- Camera/phone for photos
- Request documentation during Inspection
- Keep a record tablet or written notes, concerns, comments
- Specialist equipment supplied
- PPE
- TGD Part B
- When to terminate an Inspection
  - Works incomplete
  - No show
  - Unsafe





# Why are Fire Regularisation Certificates still in the Building Control Regulations?

• MMC expertise lacking Fingal County Council

### **Enforcement**



- Offences
  - Must have FSC before starting works 7Day Notice exception
  - Not complying with conditions = no valid FSC
  - Lying on Statutory Declaration
  - Opened, operated or occupied without granted FSC

### Action

- Non compliance with B Regs part B Enforcement Notice
- Non compliance with BC Regs summary or indictment
- Purpose of FSC
  - Compliance with Part B

### **A Final Thought - Be Safe during the inspection**
